- (A) IN THIS SECTION, "CAMERA" INCLUDES ANY ELECTRONIC DEVICE THAT CAN BE USED TO OBSERVE SURREPTITIOUSLY A PERSON.
 - (B) THIS SECTION DOES NOT APPLY TO:
 - (1) AN ADULT RESIDENT OF A PRIVATE RESIDENCE;
- (2) A PERSON WHO PLACES OR PROCURES ANOTHER TO PLACE A CAMERA ON REAL PROPERTY AND WHO DOES NOT HAVE THE INTENT OF CONDUCTING DELIBERATE SURREPTITIOUS OBSERVATION OF A PERSON INSIDE THE PRIVATE RESIDENCE;
- (3) A PERSON WHO HAS THE CONSENT OF AN ADULT RESIDENT, OR THE RESIDENT'S LEGAL GUARDIAN, TO PLACE A CAMERA ON REAL PROPERTY FOR PURPOSES OF CONDUCTING DELIBERATE SURREPTITIOUS OBSERVATION OF A PERSON INSIDE THE PRIVATE RESIDENCE;
- (4) ANY OTHERWISE LAWFUL OBSERVATION WITH A CAMERA CONDUCTED BY A LAW ENFORCEMENT OFFICER WHILE IN PERFORMANCE OF THE OFFICER'S OFFICIAL DUTIES;
- (5) FILMING BY OR FOR THE PRINT OR BROADCAST MEDIA USING A CAMERA THAT IS NOT SECRETED FROM VIEW;
- (6) ANY PORTION OF A PRIVATE RESIDENCE USED FOR BUSINESS PURPOSES, INCLUDING ANY PORTION OF A DAY CARE HOME USED FOR THE CARE AND CUSTODY OF A CHILD; OR
- (7) FILMING OF A PRIVATE RESIDENCE BY USING A CAMERA THAT IS NOT LOCATED ON THE REAL PROPERTY ON WHICH THE PRIVATE RESIDENCE IS LOCATED.
- (C) A PERSON MAY NOT PLACE OR PROCURE ANOTHER TO PLACE A CAMERA ON REAL PROPERTY ON WHICH IS LOCATED A PRIVATE RESIDENCE FOR PURPOSES OF CONDUCTING DELIBERATE SURREPTITIOUS OBSERVATION OF A PERSON INSIDE THE PRIVATE RESIDENCE.
- (D) (1) IT IS NOT A DEFENSE TO A PROSECUTION UNDER THIS SECTION THAT THE PERSON CHARGED IS THE OWNER OF THE PRIVATE RESIDENCE, IF THE OWNER IS NOT AN ADULT RESIDENT OF THE PRIVATE RESIDENCE.
- (2) A GOOD FAITH RELIANCE ON A COURT ORDER IS A COMPLETE DEFENSE TO ANY CIVIL OR CRIMINAL ACTION BROUGHT UNDER THIS SECTION.
- (E) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN \$1,000 OR IMPRISONMENT FOR NOT MORE THAN 30 DAYS 6 MONTHS OR BOTH.
- (F) A PERSON IN A PRIVATE RESIDENCE WHO WAS OBSERVED BY A CAMERA IN VIOLATION OF THIS SECTION HAS A CIVIL CAUSE OF ACTION AGAINST ANY PERSON WHO PLACED THE CAMERA OR PROCURED ANOTHER TO PLACE THE CAMERA
