A RESOLUTION TO AMEND THE CHARTER OF THE TOWN OF BLADENSBURG, MARYLAND, TO PROVIDE THAT A SPECIAL ELECTION WILL BE CALLED IF A VACANCY OCCURS IN THE OFFICE OF MAYOR OR COUNCILMAN AND MORE THAN ONE YEAR REMAINS IN THE VACANT TERM.
