A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF GAITHERSBURG, MARYLAND, TO AMEND SECTION 38 OF THE CITY CHARTER SO AS TO PROVIDE THAT VIOLATION OF SPECIFIED ELECTION ORDINANCES AND THIS CHARTER RELATING TO ELECTION MATTERS CONSTITUTE A MUNICIPAL INFRACTION AND ALSO TO INCREASE THE PENALTY FOR MISDEMEANORS FROM FIVE THOUSAND DOLLARS (\$500.00) AND/OR A MAXIMUM OF NINETY (90) DAYS IMPRISONMENT TO THE MAXIMUM ALLOWABLE VALUE BY STATE LAW OF ONE THOUSAND DOLLARS (\$1,000.00) AND/OR A MAXIMUM OF SIX (6) MONTHS IMPRISONMENT
