AN ACT concerning amendment to the Code of Public Local Laws of Queen Anne's County, Maryland, Title 18 Land Use and Development to add a new Section 18-1-238.

FOR THE PURPOSE of providing that certain administration subdivisions shall be irrevocable and prohibiting further subdivision except in certain circumstances by adding a new Section 18-1-238 to Title 18 of the Code of Public Local Laws of Queen Anne's County, Maryland.
