A BILL TO REPEAL AND REENACT SECTION 19.10(z)(2)(v) OF TITLE 19, ZONING OF THE TALBOT COUNTY CODE, AMENDING THE PROVISIONS RELATING TO ON-PREMISE SIGNS WHICH DIRECT OR GUIDE TRAFFIC, THAT ARE EXCLUDED FROM REGULATION UNDER TITLE 19, ZONING OF THE TALBOT COUNTY CODE.

A BILL TO AMEND TITLE 19, ZONING, OF THE TALBOT COUNTY CODE, BY AMENDING THE PROVISIONS OF SECTION 19.4(a) GENERAL TABLE OF LAND USE REGULATIONS, CHANGING SPECIFIC USE CONDITIONS FOR COTTAGE INDUSTRY AND ADDING HOME BASED OFFICE TO REGULATIONS FOR ACCESSORY RESIDENTIAL USES; REPEALING AND REENACTING SECTION 19.4(b)(3) HOME OCCUPATIONS; AMENDING THE PROVISIONS OF SECTION 19.2(c) TERMS DEFINED, ADDING THE DEFINITION OF HOME BASED OFFICE AND CHANGING THE TITLE OF HOME OCCUPATION TO READ HOME BASED OCCUPATION; AMENDING SECTION 19.4(b)(3) ADDITIONAL LAND USE REGULATIONS, BY ADDING PROVISIONS FOR BED AND BREAKFAST ACCOMMODATIONS AND AMENDING SECTION 19.4(a) GENERAL TABLE OF USE REGULATIONS BY ZONING DISTRICT, TO CORRECT THE SECTION REFERENCE FOR A BED AND BREAKFAST.
