

2. IF THE LICENSE IS FOR A MOBILE UNIT, THE VEHICLE IDENTIFICATION NUMBER OF THE MOBILE UNIT AND THE GEOGRAPHIC AREA IN WHICH THE MOBILE UNIT WILL BE OPERATING; AND

(III) ANY OTHER INFORMATION THAT THE COMMISSIONER REQUIRES FOR AN INVESTIGATION AND FINDINGS UNDER § 12-109 OF THIS SUBTITLE.

(B) WITH THE APPLICATION, THE APPLICANT SHALL PAY TO THE COMMISSIONER:

- (1) AN INVESTIGATION FEE OF \$100; AND
- (2) A LICENSE FEE OF:

(I) \$1,000 IF THE APPLICANT APPLIES FOR A LICENSE TO BE ISSUED ON OR AFTER JANUARY 1 AND ON OR BEFORE DECEMBER 31 OF AN EVEN-NUMBERED YEAR; OR

(II) \$500 IF THE APPLICANT APPLIES FOR A LICENSE TO BE ISSUED ON OR AFTER JANUARY 1 AND ON OR BEFORE DECEMBER 31 OF AN ODD-NUMBERED YEAR.

~~(C) (1) WITH THE APPLICATION, THE APPLICANT SHALL FILE WITH THE COMMISSIONER A SURETY BOND.~~

~~(2) THE SURETY BOND FILED UNDER THIS SUBSECTION SHALL RUN TO THE STATE FOR THE BENEFIT OF INDIVIDUALS WHO HAVE BEEN DAMAGED BY A VIOLATION OF ANY LAW OR REGULATION GOVERNING CHECK CASHING SERVICES THAT IS COMMITTED BY A LICENSEE.~~

~~(3) THE SURETY BOND SHALL BE:~~

~~(I) IN THE AMOUNT OF AT LEAST \$50,000;~~

~~(II) ISSUED BY A SURETY COMPANY AUTHORIZED TO DO BUSINESS IN THE STATE;~~

~~(III) CONDITIONED SO THAT THE APPLICANT SHALL COMPLY WITH ALL LAWS REGULATING THE PROVISION OF CHECK CASHING SERVICES; AND~~

~~(IV) APPROVED BY THE COMMISSIONER.~~

~~(C)~~ (C) (1) SUBJECT TO THE PROVISIONS OF PARAGRAPH (2) OF THIS SUBSECTION, IF AN APPLICANT APPLIES FOR MORE THAN ONE LICENSE, AS TO EACH LICENSE THE APPLICANT SHALL:

(I) SUBMIT A SEPARATE APPLICATION; AND

(II) PAY A SEPARATE INVESTIGATION FEE AND LICENSE FEE.

(2) AN APPLICANT THAT APPLIES FOR MORE THAN ONE LICENSE IS NOT REQUIRED TO PROVIDE FINGERPRINTS FOR A CRIMINAL HISTORY RECORDS CHECK FOR MORE THAN ONE APPLICATION.
