- (I) INVOLVED THE EXCHANGE OF VALUE OF \$1,000 OR MORE FOR A SINGLE TRANSACTION OR INVOLVED THE EXCHANGE OF VALUE OF \$5,000 OR MORE FOR A SERIES OF TRANSACTIONS: AND
  - (II) OCCURRED IN THE PREVIOUS 12 6 MONTHS.
- (2) (3) A AN INDIVIDUAL REGULATED LOBBYIST IS SUBJECT TO THE REPORTING REQUIREMENTS OF THIS SECTION IF THE INDIVIDUAL REGULATED LOBBYIST ENGAGES IN A BUSINESS TRANSACTION WITH:
  - (I) A MEMBER OF THE GENERAL ASSEMBLY;
  - (II) THE GOVERNOR;
  - (III) THE LIEUTENANT GOVERNOR;
  - (IV) THE ATTORNEY GENERAL;
  - (V) THE SECRETARY OF STATE;
  - (VI) THE COMPTROLLER OF THE TREASURY;
  - (VII) THE STATE TREASURER;
  - (VIII) THE SECRETARY OF ANY PRINCIPAL STATE DEPARTMENT;
- (IX) THE SPOUSE OF AN INDIVIDUAL LISTED IN ITEMS (I) THROUGH (VIII) OF THIS PARAGRAPH;
- (X) A BUSINESS ENTITY IN WHICH AN INDIVIDUAL LISTED IN ITEMS (I) THROUGH (IX) OF THIS PARAGRAPH PARTICIPATES AS A PROPRIETOR OR PARTNER; OR
- $(\rm XI)~$  A BUSINESS ENTITY WHERE AN INDIVIDUAL LISTED IN ITEMS (I) THROUGH (IX) OF THIS PARAGRAPH HAS AN OWNERSHIP INTEREST OF AT LEAST 30% IN THE ENTITY.
- $\stackrel{ ext{(2)}}{ ext{(4)}}$  THE DISCLOSURE REQUIRED UNDER THIS SUBSECTION SHALL INCLUDE:
- $\,$  (I)  $\,$  The date of the business transaction or dates of each of the series of transactions;
- (II) THE NAME AND TITLE OF THE OFFICIAL LISTED IN PARAGRAPH (2) OF THIS SUBSECTION WHO WAS INVOLVED IN EACH BUSINESS TRANSACTION OR SERIES OF TRANSACTIONS; AND
  - (III) THE NATURE AND VALUE OF ANYTHING EXCHANGED.
- [(f)] (G) The Ethics Commission may require a regulated lobbyist to file any additional report the Ethics Commission determines to be necessary.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2000.
