- (C) THE ANNUAL DEPMIT FEE IS \$150.
- (D) (1) AN APPLICATION FOR A WT PERMIT SHALL BE MADE ON A FORM THAT THE BOARD OF LICENSE COMMISSIONERS FOR WICOMICO COUNTY PROVIDES.

**VETOES** 

- (2) A RENEWAL OF A WT PERMIT MAY BE MADE AT THE TIME THE CLASS A BEER AND WINE (OFF SALE) LICENSE IS RENEWED.
- (3) WITHOUT A-HEARING, THE-BOARD MAY APPROVE OR DENY AN APPLICATION FOR A WT PERMIT.
- (4) IF AN APPLICATION FOR A WT PERMIT IS DENIED, ON THE APPLICANT'S REQUEST THE BOARD SHALL HOLD A PUBLIC HEARING TO RECONSIDER THE APPLICATION.
- (E) A WT PERMIT HOLDER SHALL NOTIFY THE BOARD IN WRITING AT LEAST 5 BUSINESS DAYS BEFORE EACH WINE TASTING OR SAMPLING EVENT.
- (F) (1) A WT PERMIT HOLDER MAY NOT MIX THE CONTENTS OF ONE BOTTLE WITH ANOTHER
- (2) ONCE OPENED, EACH BOTTLE USED FOR THE WINE TASTING OR SAMPLING EVENT SHALL BE MARKED THAT IT IS TO BE USED ONLY FOR THAT EVENT.
- (3) A WT PERMIT HOLDER SHALL DESTROY EACH BOTTLE AFTER IT IS EMPTY.
  - (C) A WT PERMIT HOLDER MAY NOT.
- (1) SERVE TO ANY PERSON FOR TASTING OR SAMPLING PURPOSES MORE THAN 2 OUNCES FROM EACH BRAND NOR MORE THAN SIX SAMPLES PER DAY;
  - (2) HAVE OPEN MORE THAN SIX BOTTLES OF WINE AT ONCE:
- (3) HOLD WINE TASTING OR SAMPLING EVENTS ON MORE THAN 15 DAYS DURING EACH PERMIT PERIOD: AND
- (4) CONDUCT WINE TASTING OR SAMPLING FROM A DRIVE THROUGH WINDOW.
  - (A) THIS SECTION APPLIES ONLY IN WICOMICO COUNTY.
- (B) (1) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A WINE TASTING (WT) LICENSE FOR WINE TASTING AND SAMPLING.
- (2) <u>A WT LICENSE MAY BE ISSUED ONLY TO A HOLDER OF A CLASS A</u> BEER AND WINE (OFF-SALE) LICENSE.
  - (C) THE ANNUAL WT LICENSE FEE IS \$150.
- (D) (1) AN APPLICATION FOR A WT LICENSE SHALL BE MADE ON A FORM THAT THE BOARD OF LICENSE COMMISSIONERS PROVIDES.
