(<u>L</u>) (<u>K</u>) "TECHNICAL ASSISTANCE GRANT" MEANS A GRANT AWARDED BY THE PROGRAM, WHICH ENABLES A LOCAL GOVERNMENT OR A NONPROFIT ORGANIZATION TO PROVIDE TECHNICAL ASSISTANCE TO OWNER-BUILDERS AND SELF-HELP REHABILITATORS.

- (A) THERE IS A SELF-HELP HOMEOWNERSHIP TECHNICAL ASSISTANCE PROGRAM IN THE DEPARTMENT.
- (B) THE PURPOSE OF THE PROGRAM IS TO MAKE GRANTS FOR TECHNICAL ASSISTANCE TO EXPAND:
- (1) THE PRODUCTION OF DECENT AFFORDABLE HOUSING FOR FAMILIES OF LIMITED INCOME THROUGH THE USE OF SELF-HELP METHODS OF REHABILITATION AND CONSTRUCTION;
- (2) THE HOMEOWNERSHIP OPPORTUNITIES FOR THOSE TO WHOM IT WOULD OTHERWISE NOT BE AVAILABLE WITHOUT THE COST SAVINGS ACHIEVED BY THE SELF-HELP METHOD; AND
- (3) SELF-RELIANCE, PRIDE OF OWNERSHIP, AND SENSE OF COMMUNITY FOR THOSE WHO PARTICIPATE.
