- (A) THE DEPARTMENT MAY AWARD TECHNICAL ASSISTANCE GRANTS TO LOCAL JURISDICTIONS AND NONPROFIT ORGANIZATIONS TO PROVIDE ASSISTANCE TO FAMILIES OF LIMITED INCOME WHO ARE OWNER-BUILDERS OR SELF-HELP REHABILITATORS FOR THE FOLLOWING PURPOSES:
- (1) ASSISTANCE, TRAINING, AND SUPERVISION ON SELF-HELP CONSTRUCTION ACTIVITIES AND TECHNIQUES;
- (2) ASSISTANCE IN PROJECT DEVELOPMENT WHICH INCLUDES, BUT IS NOT LIMITED TO, THE PREPARATION OF PLANS FOR SELF-HELP HOUSING, PREPARATION OF CONTRACTS FOR PROFESSIONAL SERVICES, APPLICATION FOR PROJECT FUNDING, PACKAGING HOUSEHOLDS' APPLICATIONS FOR ASSISTANCE, PREPARATION OF SUBDIVISION MAPS, REVIEW OF ENGINEERING PLANS AND SPECIFICATIONS FOR CONSTRUCTION AND REHABILITATION PROJECTS, AND COMPLIANCE WITH APPROPRIATE REQUIREMENTS OF FUNDING AGENCIES AND LOCAL GOVERNMENT; AND
- (3) ADMINISTRATIVE COSTS OF PROVIDING TECHNICAL ASSISTANCE FOR THE ACTIVITY FUNDED BY THE DEPARTMENT.
