Article – Education Section 3–904 Annotated Code of Maryland (1999 Replacement Volume)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Education

3-904.

- (A) THE MONTGOMERY COUNTY EXECUTIVE SHALL ESTABLISH A MONTGOMERY COUNTY SCHOOL BOARD COMPOSITION TASK FORCE TO STUDY THE AUTHORITY, SIZE, COMPOSITION, AND THE RESPONSIBILITIES OF THE MONTGOMERY COUNTY BOARD OF EDUCATION.
 - (B) (1) THE TASK FORCE SHALL CONSIST OF 16 MEMBERS.
- (2) THE PRESIDENT OF THE SENATE SHALL APPOINT TWO MEMBERS FROM THE MONTGOMERY COUNTY SENATE DELEGATION.
- (3) THE SPEAKER OF THE HOUSE SHALL APPOINT TWO MEMBERS FROM THE MONTGOMERY COUNTY HOUSE DELEGATION.
 - (4) THE MONTGOMERY COUNTY EXECUTIVE SHALL APPOINT:
 - (I) TWO MEMBERS FROM THE MONTGOMERY COUNTY COUNCIL:
- (II) TWO MEMBERS FROM THE MONTGOMERY COUNTY BOARD OF EDUCATION;
- (III) ONE MEMBER FROM THE MONTGOMERY COUNTY EDUCATION ASSOCIATION,
- (IV) ONE MEMBER FROM THE MONTGOMERY COUNTY COUNCIL OF SUPPORTING SERVICES EMPLOYEES:
- (V) ONE MEMBER FROM THE MONTGOMERY COUNTY ASSOCIATION OF ADMINISTRATIVE AND SUPERVISORY PERSONNEL;
- (VI) ONE MEMBER FROM THE MONTGOMERY COUNTY REGIONAL STUDENT GOVERNMENTS:
- (VII) ONE MEMBER FROM THE MONTGOMERY COUNTY COUNCIL OF PARENT TEACHER ASSOCIATIONS; AND

(VIII) THREE MEMBERS FROM THE GENERAL PUBLIC.

- (C) . THE MONTGOMERY COUNTY EXECUTIVE SHALL SELECT THE CHAIR OF THE TASK FORCE.
 - (D) (1) TEN MEMBERS OF THE TASK FORCE SHALL CONSTITUTE A QUORUM.
