- (f) (1) Service of process on a resident agent of a local entity constitutes effective service of process under the Maryland Rules on the local entity in an action, suit, or proceeding that is pending, filed, or instituted against the local entity.
- (2) Any notice required by law to be served by personal service on a resident agent or other agent or officer of a local entity may be served in the manner provided by the Maryland Rules relating to service of process on local entities.
- (3) Service under the Maryland Rules is equivalent to personal service on a resident agent or other agent or officer of a local entity.
