## TITLE 2. COUNCIL MEMBERSHIP AND DUTIES.

## SUBTITLE 1. MEMBERSHIP.

2-101.

- (A) THE MEMBERSHIP OF THE COUNCIL CONSISTS OF THE FOLLOWING MEMBERS FROM CAROLINE, GECIL, DORCHESTER, KENT, QUEEN ANNES, AND TALBOT COUNTIES:
- (1) 18 9 COUNTY-ELECTED-OFFICIALS COMMISSIONERS, THREE FROM EACH COUNTY, APPOINTED BY THEIR RESPECTIVE COUNTY GOVERNING BODIES AS VOTING MEMBERS;
- (2) SIX <u>THREE</u> COUNTY ADMINISTRATORS, ONE FROM EACH COUNTY AS NONVOTING EX OFFICIO MEMBERS;
- (3) (I) SIX <u>THREE</u> MUNICIPAL ELECTED OFFICIALS, ONE FROM EACH COUNTY, APPOINTED BY THEIR RESPECTIVE MUNICIPAL CORPORATIONS AS VOTING MEMBERS; OR
- (II) IF THE MUNICIPAL CORPORATIONS LOCATED IN A COUNTY ARE UNABLE. TO CHOOSE A MUNICIPAL ELECTED OFFICIAL WITHIN A REASONABLE PERIOD OF TIME, THE EASTERN SHORE MUNICIPAL ASSOCIATION SHALL APPOINT AN ELECTED MUNICIPAL OFFICIAL TO REPRESENT THE MUNICIPAL CORPORATION;
- (4) MEMBERS OF THE GENERAL ASSEMBLY REPRESENTING THE REGION WHO HAVE A MAJORITY OF THEIR LEGISLATIVE DISTRICT IN THE REGION AS VOTING EX OFFICIO MEMBERS:
- (5) MEMBERS OF THE GENERAL ASSEMBLY REPRESENTING THE REGION WHO DO NOT HAVE A MAJORITY OF THEIR LEGISLATIVE DISTRICT IN THE REGION AS NONVOTING EX OFFICIO MEMBERS; AND
- (6) SUCH  $\underline{THE}$  OTHER COUNTY COMMISSIONERS AS NONVOTING EX OFFICIO MEMBERS.
- (B) (1) A COUNCIL VOTING COMMISSIONER OR ADMINISTRATOR OF A COUNTY LISTED UNDER SUBSECTION (A)(1) AND (2) OF THIS SECTION MAY DESIGNATE ANOTHER COMMISSIONER OR COUNTY ADMINISTRATOR REPRESENTING THE SAME COUNTY TO VOTE BY PROXY ON BEHALF OF AN OTHER COUNCIL MEMBER WHO THE VOTING COMMISSIONER WHEN THE VOTING COMMISSIONER IS ABSENT FROM A MEETING IF THE OTHER COUNCIL MEMBER REPRESENTS THE SAME COUNTY COVERNING BODY.
- (2) A COUNCIL MEMBER VOTING COMMISSIONER LISTED UNDER SUBSECTION (A)(1) OF THIS SECTION SHALL INFORM THE COUNCIL EXECUTIVE DIRECTOR, IN ADVANCE, OF WHICH OTHER COUNCIL MEMBERS MAY THE VOTING COMMISSIONER DESIGNATES TO CAST A PROXY VOTE ON BEHALF OF THE COUNCIL MEMBER WHEN ABSENT UNDER THE PROVISIONS OF PARAGRAPH (1) OF THIS SUBSECTION VOTING COMMISSIONER.
