~~(K) (1) (I) EACH CMRS PROVIDER SHALL SUBMIT EACH YEAR TO THE BOARD AN ESTIMATE OF RECURRING COSTS OF DEPLOYING WIRELESS ENHANCED 911 SERVICE FOR EACH LINE OR NUMBER IN THE SUBSCRIBER BASE. THE CMRS PROVIDER SHALL CALCULATE THE ESTIMATE BASED ON THE THEN CURRENT DEPLOYMENT OF WIRELESS ENHANCED 911 SERVICE IN ALL AREAS OF THE STATE IN WHICH THE CMRS PROVIDER PROVIDES WIRELESS SERVICE.~~

~~(H) A CMRS PROVIDER SHALL SUBMIT TO THE BOARD AN ESTIMATE OF NONRECURRING COSTS OF DEPLOYING WIRELESS ENHANCED 911 SERVICE IN ORDER TO OBTAIN APPROVAL OF THE COSTS.~~

~~(HH) THE BOARD SHALL COMPLETE ITS REVIEW AND APPROVE OR REJECT THE ESTIMATED COSTS THAT A CMRS PROVIDER SUBMITS UNDER SUBSECTION (H)(11) OF THIS SECTION WITHIN 90 DAYS AFTER RECEIVING THE ESTIMATED COSTS FROM THE CMRS PROVIDER.
