A CHARTER AMENDMENT TO DELETE THE REQUIREMENT THAT ALL TOWN CHECKS BE ISSUED AND SIGNED BY THE CLERK-TREASURER AND SIGNED BY THE MAYOR AND PROVIDE IN LIEU THEREOF THAT ALL CHECKS ISSUED IN PAYMENT OF SALARIES OR OTHER MUNICIPAL OBLIGATIONS SHALL BE SIGNED BY TWO TOWN OFFICIALS, AT LEAST ONE OF WHOM SHALL BE THE MAYOR OR THE CLERK-TREASURER; THE COUNCIL, BY RESOLUTION, MAY DESIGNATE ADDITIONAL OFFICIALS TO CO-SIGN CHECKS WITH THE MAYOR OR CLERK-TREASURER; AND ANY SUCH ADDITIONAL OFFICIAL SHALL BE EITHER A COUNCIL MEMBER OR A BONDED EMPLOYEE OF THE TOWN
