Reorganization - Budget and Finance

FOR the purpose of abolishing the Office of Budget and Finance; creating an Office of the Budget and an Office of Finance; eliminating the position of Financial Officer and creating the positions of Budget Officer and Controller; providing for the duties and authorities of the Office of the Budget, the Office of Finance, the Budget Officer and the Controller; making certain transitional provisions; and generally relating to budget and finance.
