[Effective Date October 21, 2000]

Bill No. 794, 2000 Legislative Session

A BILL TO AMEND TITLE 19, ZONING, OF THE TALBOT COUNTY CODE, TO REPEAL AND REENACT SECTION 19.4 (b). (11) BED AND BREAKFAST ACCOMMODATIONS, REMOVING PARAGRAPH [f] LIMITING THE USE OF A BED AND BREAKFAST ESTABLISHMENT TO TWENTY-FIVE (25) PERCENT OF THE GROSS FLOOR AREA OF A SINGLE FAMILY DWELLING UNIT.

Bill No. 795, 2000 Legislative Session

A BILL TO AMEND SECTION 7 B-2 OF THE TALBOT COUNTY CODE TO ADD AN AT-LARGE SEAT AND TO AUTHORIZE THE COUNTY COUNCIL TO ANNUALLY APPOINT THE CHAIRPERSON OF THE EMERGENCY SERVICES MANAGEMENT ADVISORY BOARD.

Bill No. 799, 2000 Legislative Session

A BILL TO AMEND SECTIONS 7 B-1 AND 7 B-2 OF THE TALBOT COUNTY CODE TO CHANGE THE NAME OF THE "EMERGENCY SERVICES MANAGEMENT ADVISORY BOARD" TO "EMERGENCY MEDICAL SERVICES MANAGEMENT ADVISORY BOARD" AND TO PROVIDE THAT THE MEMBERS OF THE BOARD SHALL ANNUALLY ELECT A CHAIRPERSON AND VICE-CHAIRPERSON.

Bill No. 800, 2000 Legislative Session

A BILL TO AMEND TITLE 19 ("ZONING") OF THE TALBOT COUNTY CODE BY AMENDING SECTION 19.4(a) ("GENERAL TABLE OF USE REGULATIONS BY ZONING DISTRICTS") TO CHANGE "UTILITY STRUCTURES AND SERVICES" TO A NEW USE ENTITLED "UTILITY SERVICES, NONESSENTIAL" AND TO CHANGE "FLAMMABLE LIQUID STORAGE AND WHOLESALE DISTRIBUTION" TO A NEW USE ENTITLED "STORAGE OF FLAMMABLE LIQUIDS FOR RESALE" AND TO AMEND SECTION 19.2(c) ("TERMS DEFINED") TO REDEFINE "UTILITY SERVICES, ESSENTIAL" AND "UTILITY TRANSMISSION FACILITIES" AND TO CREATE A NEW DEFINITION FOR "UTILITY SERVICES, NONESSENTIAL".
