

COUNTY LOCAL LAWS

[Effective Date April 22, 2000]

Bill No. 2000-5

AN ACT to amend Chapter 203 of the Wicomico County Code, entitled "Taxation," by amending Article X entitled "Transfer Tax" to impose a One percent (1%) transfer tax on instruments of writing, by adding Section 203-24 entitled "Imposition, Exemptions, Rate and Calculation of Tax", Section 203-25 entitled "Duties of Director", Section 203-26 entitled "Duties of Clerk", Section 203-27 entitled "Distribution," Section 203-28 entitled "Penalty," and Section 203-29 entitled "Grandfather provisions."

[Effective Date May 31, 2000 – Repealed November 12, 2000 by Referendum]

Bill No. 2000-6

AN ACT to delete Chapter 66 of the Wicomico County Code, titled "Plats," amend Chapter 77, titled "Roads and Improvements," Section 77-1, entitled "Jurisdiction," 77-6, entitled "General powers of Council," and amend Chapter 197, titled "Streets and Addressing System," by the addition of a new Article III, entitled "Streets and Roads," to include Section 197-12, "Definitions," Section 197-13, "General," Section 197-14, "Procedure for Opening Streets and Roads," Section 197-15, "Altering, Relocating or Closing Streets and Roads," and Section 197-16, "Dedications," to establish a uniform procedure for the acceptance of county roads, and the opening, relocation and closing thereof.

Bill No. 2000-07

AN ACT to amend Chapter 138 of the Wicomico County Code, titled "Electrical Standards," Section 138-6, entitled "Compensation and expenses," to delete the provision requiring compensation of the Secretary-Treasurer of the Board of Electrical Examiners in the amount of \$75.00 per year.

AN ACT to amend Chapter 105 titled "Alarms", Chapter 126, titled "Forest Conservation," Chapter 133, titled "Dogs and Other Animals," Chapter 156, titled "Garbage, Rubbish and Refuse," Chapter 174, titled "Nuisances," Chapter 183, titled "Plumbing," Chapter 186, titled "Right to Farm," Chapter 197, titled "Streets and Addressing System," Chapter 205, titled "Taxicabs," and Chapter 225, titled "Zoning," of the Wicomico County Code, and to add Chapter 221, titled "Violations and Penalties," to the Wicomico County Code to include Section 221-1 titled "Definitions", Section 221-2 titled "Fines", Section 221-3 titled "Procedure", Section 221-4 titled
