AN ACT to amend Chapter 179 of the Wicomico County Code, entitled "Parks, Recreational Facilities and Areas," by amending Section 179-3 X, entitled "Traffic and Parking," and by adding Section 179-14 entitled "Authority to Issue Citations", and to amend Chapter 197, entitled "Streets and Addressing System,," by the addition of a new Article IV, entitled "Stopping, Standing and Parking" to include Section 197-17, entitled "Definitions", Section 197-18, entitled "Authority to Issue Citations", Section 197-19, entitled "Stopping, Standing and Parking Violations", Section 197-20, entitled "Violations and Penalties", Section 197-21, entitled "Issuance of Citations", Section 197-22, entitled "Persons Responsible For Infractions And Effect of Infractions on Motor Vehicle Registration," Section 197-23, entitled "Payment of Fine; Election to Stand Trial; Additional Penalties," Section 197-24, entitled "Adjudication of Citations;" and by the addition of a new Article V, entitled "Permit Parking" to include Section 197-25, entitled "Authority to Establish Permit Parking Areas", Section 197-26, entitled "Authority to Issue Parking Permits", Section 197-27, entitled "Applications For Parking Permits", Section 197-28, entitled "Issuance of Parking Permits", Section 197-29, entitled "Temporary Parking Permits", Section 197-30, entitled "Display of Parking Permits", Section 197-31, entitled "Surrender of Permit", Section 197-32, entitled "Representations in Application And Use of Permit", Section 197-33, entitled "Violations And Penalties", and Section 197-34, entitled "Exemptions"; and by adding Section 197-35, entitled "Severability;" to make stopping, standing and parking infractions subject to provisions of Md. Ann. Code, § 26-301 et seq. of the Transportation Article and, so far as practicable, consistent with enforcement provisions for other civil infractions of the Wicomico County Code and to authorize, establish and codify a permit parking procedure.
