SECTION 5. AND BE IT FURTHER ENACTED, That, notwithstanding the provisions of § 14 405 of the Education Article or any other provision of law, in fiscal year 2004 the State General Fund appropriation to St. Mary's College of Maryland shall not exceed \$14,315,970.

SECTION 6. AND BE IT FURTHER ENACTED, That, notwithstanding the provisions of § 7-325 of the State Finance and Procurement Article or any other provision of law, in fiscal year 2004 the State General Fund appropriation to the State Arts Council shall not exceed \$12,280,142.

SECTION 7. AND BE IT FURTHER ENACTED, That, notwithstanding the provisions of Chapter 439 of the Acts of 2002 (the Budget Bill for Fiscal Year 2003), Section 29, funds appropriated to the various State departments and agencies in Comptroller object 0182 (Employee Transit Expenses), for the use of Baltimore area transit services by State employees shall not be transferred or expended for any purpose and the general fund share of all such appropriations shall revert to the General Fund of the State.

SECTION 8. AND BE IT FURTHER ENACTED, That, notwithstanding the provisions of § 32–205 of the State Personnel and Pensions Article, in fiscal year 2004 the State shall not be required to make the employer contributions to the applicable State supplemental plan for participating employees in the Optional Defined Contribution System.

SECTION 8. AND BE IT FURTHER ENACTED, That the unexpended appropriations for the following purposes that were included in the fiscal year 2003 operating budget (Chapter 439, Acts of 2002) are reduced by the amounts indicated below and are hereby transferred to the State General Fund:

SECTION 9. AND BE IT FURTHER ENACTED, That, notwithstanding any provision of law, State employees employed by any entity to which funds are appropriated in the State budget, including the University System of Maryland, Morgan State University, and St. Mary's College of Maryland, shall not receive bonuses related to individual performance, merit increases, or cost-of-living adjustments in fiscal year 2004. This provision shall not affect salaries for constitutional officers or members of the General Assembly or increases necessary for the retention of faculty in the University System of Maryland, Morgan State University, or St. Mary's College of Maryland.
