- (D) AT ANY TIME FOLLOWING DECEMBER 1 OF EACH FISCAL YEAR, THE DEPARTMENT MAY TRANSFER, SUBJECT TO THE PROVISIONS OF § 7 200 OF THE STATE FINANCE AND PROCUREMENT ARTICLE, UNENCUMBERED MONEYS IN THE NEIGHBORHOOD INTERVENTION FUND TO THE COMMUNITY LEGACY FINANCIAL ASSISTANCE FUND EXCEPT AS MAY BE PROVIDED IN THE STATE BUDGET.
