~~(4) FOR TAKING OYSTERS FROM AN OYSTER SANCTUARY OR OYSTER RESERVE THAT IS DESIGNATED AND MARKED BY BUOYS, BUOYS OR OTHER SIGNAGE, AND WHO KNEW OR SHOULD HAVE KNOWN THAT TAKING THE OYSTERS FROM THE SANCTUARY OR RESERVE WAS UNLAWFUL, SHALL BE SUBJECT TO A FINE NOT EXCEEDING \$3,000 AND IMMEDIATE REVOCATION SUSPENSION OF A THE PERSON'S TIDAL FISH LICENSE FOR A PERIOD NOT LESS THAN 2 YEARS 6 MONTHS BUT NOT MORE THAN 5 YEARS 1 YEAR.~~

(House Bill 470)

AN ACT concerning

Forest Conservation

FOR the purpose of altering a certain notice requirement after submission of a forest conservation plan; requiring the State to develop certain provisions relating to the development of a forest conservation program; requiring the deposit of certain funds in the Forest Conservation Fund; and generally relating to forest conservation.
