- (a) The following moneys shall be considered general funds of the State:
- (1) [all] EXCEPT AS PROVIDED UNDER § 6–107 OF THIS ARTICLE, revenue received under Title 6, Subtitle 1 of this article;
- (2) all revenue received under $\S\S$ 3–324, 4–209, 6–303, and 6–304 of this article; and
