- (3) PROVIDE INFORMATION AS REQUIRED BY SUBSECTION (D) OF THIS SECTION TO—SHOW THAT THE APPLICANT MEETS ONE OF THE FOLLOWING CONDITIONS:
- (I) THE APPLICANT IS CURRENTLY REGISTERED IN ANOTHER COUNTY IN THE STATE BUT HAS MOVED TO A NEW COUNTY WHERE THE APPLICANT SEEKS TO VOTE; OR
- (II) THE APPLICANT HAS, WITHIN THE LAST 2 YEARS, MADE A GOOD FAITH EFFORT TO REGISTER TO-VOTE OR TO UPDATE A VOTER REGISTRATION RECORD: OR
- (III) THE APPLICANT MEETS ANY OTHER CRITERIA PRESCRIBED BY RECULATIONS OF THE STATE BOARD.
 - (D) TO MAKE THE SHOWING REQUIRED BY SUBSECTION (CX3) OF THIS
- (II) THE APPLICANT HAS, WITHIN THE LAST 2 YEARS MADE A TIMELY EFFORT TO REGISTER TO VOTE OR UPDATE A VOTER REGISTRATION RECORD AND, FOLLOWING THE TRANSACTION, BELIEVED IN GOOD FAITH THAT, WITHOUT FURTHER ACTION ON THE PART OF THE APPLICANT, THE REQUIREMENTS FOR REGISTRATION OR FOR UPDATING THE REGISTRATION RECORD HAD BEEN SATISFACTORILY COMPLETED.

- (1) IF THE APPLICANT IS CURRENTLY REGISTERED TO VOTE IN THE STATE, IDENTIFY THE COUNTY WHERE THE APPLICANT HAS BEEN $\underline{\text{IS}}$ REGISTERED; OR
- (2) IF THE APPLICANT HAS ATTEMPTED TO REGISTER OR UPDATE A VOTER REGISTRATION RECORD, PROVIDE:
