(4) COMMUNITY AWARENESS PROMOTION AND TRAINING PROGRAMS;
AND

(5) AN EVALUATION OF OUTCOMES OF SERVICES THROUGH AN ANNUAL SURVEY BY THE ADMINISTRATION OF CONSUMERS AND FAMILY MEMBERS WHO HAVE RECEIVED SERVICES FROM THE CRISIS RESPONSE SYSTEM.

(B) THE CRISIS RESPONSE SYSTEM SERVICES SHALL BE IMPLEMENTED AS DETERMINED BY THE CORE SERVICE AGENCY SERVING EACH JURISDICTION OR REGION.

(C) AN ADVANCE DIRECTIVE FOR MENTAL HEALTH SERVICES UNDER § 5-602.1 OF THIS ARTICLE SHALL APPLY TO THE DELIVERY OF SERVICES UNDER THIS SUBTITLE.

(D) THIS SUBTITLE MAY NOT BE CONSTRUED TO AFFECT PETITIONS FOR EMERGENCY EVALUATIONS UNDER § 10-622 OF THIS TITLE.

~~(A) THE GOVERNOR SHALL INCLUDE IN THE STATE BUDGET SUFFICIENT FUNDS TO IMPLEMENT THE CRISIS RESPONSE SYSTEM AS FEDERAL FUNDS AND OTHER SOURCES BECOME AVAILABLE.~~

~~(B) THE SECRETARY MAY RECEIVE ADDITIONAL FUNDS FROM THE UNITED STATES GOVERNMENT OR ANY OTHER PUBLIC OR PRIVATE ENTITY FOR THE CRISIS RESPONSE SYSTEM.~~

(A) THE STATE MAY NOT EXPEND MORE THAN \$250,000 IN STATE GENERAL FUNDS IN EACH FISCAL YEAR TO IMPLEMENT THE MARYLAND MENTAL HEALTH CRISIS RESPONSE SYSTEM.

(B) THE ADMINISTRATION SHALL IMPLEMENT THE CRISIS RESPONSE SYSTEM, IN COLLABORATION WITH CORE SERVICE AGENCIES, ON A REGIONAL OR JURISDICTIONAL BASIS AS FEDERAL FUNDING OR FUNDING FROM OTHER SOURCES BECOMES AVAILABLE.

THE CRISIS RESPONSE SYSTEM PROVIDERS SHALL CONTRACT WITH SERVICE PROVIDERS WHO EMPLOY INDIVIDUALS WHO USE OR HAVE USED MENTAL HEALTH SERVICES.

SECTION 2. AND BE IT FURTHER ENACTED, That Section 1 of this Act is contingent on the receipt of federal funding or funding from any other private or public source to implement the Maryland Mental Health Crisis Response System established under Section 1 of this Act.
