AND BE IT FURTHER ENACTED, That on or before June 30 of each year each contracting unit shall report to the Department of Budget and Management, and on or before September 30 of each year the Department shall report September 30 of each year, the Department of Budget and Management shall generate, from the State's electronic financial management information system, a report on the impact of this Act. The report shall be provided to the Governor and, in accordance with § 2-1246 of the State Government Article, the Senate Education, Health, and Environmental Affairs Committee and the House Commerce and Government Matters Committee, on the impact of this Act, including The report shall include, for the previous fiscal year:~~
