A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS THERETO) TITLED "CORPORATIONS-MUNICIPAL"; TO AMEND THE CHARTER OF HAVRE DE GRACE, MARYLAND, BY REPEALING SECTIONS 80 AND 85 AND REENACTING SECTION 80.

**(Charter Amendment: 2001 Annexation)**

A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ENLARGING THE CORPORATE BOUNDARIES OF THE CITY OF HAVRE DE GRACE BY ANNEXING LAND CONTIGUOUS AND ADJOINING THE EXISTING CORPORATE AREA OF THE CITY OF HAVRE DE GRACE LOCATED BETWEEN THE BAYVIEW ESTATES SUBDIVISION ON THE WEST AND THE FABRIZIO, STENGER AND WALLACE PROPERTIES THAT ARE ADJACENT TO THE CHAPEL TERRACE SUBDIVISION ON THE EAST, AND EXTENDING FROM THE CENTERLINE OF CHAPEL ROAD ON THE NORTH GENERALLY SOUTHERLY TO THE BAYVIEW ESTATES SUBDIVISION, AND CONSISTING OF 16.55 ACRES, MORE OR LESS, MORE COMMONLY KNOWN AS THE OLD FIREWORKS FACTORY OR FABRIZIO/STENGER PROPERTY AND TO BE KNOWN HENCEFORTH AS THE GRACE MANOR SUBDIVISION, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS THERETO) TITLED "CORPORATIONS-MUNICIPAL"; TO AMEND THE APPENDIX OF THE CHARTER OF THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, BY ADDING A NEW SUBSECTION A.19., ENTITLED "THE 2001 ADDITION TO THE CITY BOUNDARIES", ENLARGING THE BOUNDARIES OF THE CITY OF HAVRE DE GRACE.
