

TALBOT COUNTY

ADMINISTRATIVE BOARD TO BE KNOWN AS "THE GOLF BOARD" TO OVERSEE THE HOG NECK GOLF COURSE AND OTHER GOLF ACTIVITIES, AND TO DEFINE ITS COMPOSITION, POWERS, AND FUNCTIONS.

Bill No. 808, 2001 Legislative Session

A BILL TO AMEND SECTION 19.2, 19.3(a)(1) AND 19.4(a) OF THE TALBOT COUNTY ZONING ORDINANCE, FOR THE PURPOSE OF CLARIFYING THE DEFINITION OF BUILDING SUPPLIES, CLARIFYING THAT DESCRIPTIONS OF ZONING DISTRICTS CONTAINED IN SECTION 19.3(a)(1) ARE ILLUSTRATIVE IN NATURE AND ACTUAL USES PERMITTED BY ZONING DISTRICT ARE GOVERNED BY "GENERAL TABLE OF LAND USE REGULATIONS," AND FURTHER CLARIFYING THAT THE USE OF "BUILDING SUPPLY AND LUMBER YARDS WITH OUTSIDE STORAGE," INCLUDES HOME IMPROVEMENT CENTERS; AND TO AMEND SECTION 19.12(a)(5)(iii) AND (iv) OF THE TALBOT COUNTY ZONING ORDINANCE, TO CLARIFY THE SCOPE OF THE PLANNING OFFICER'S AND PLANNING COMMISSION'S REVIEW AUTHORITY RELATING TO AN APPLICATION FOR SITE PLAN REVIEW UNDER SECTION 19.12. SO THAT THE SAME IS CONSISTENT WITH THE COUNTY CHARTER AND OTHER COUNTY CODE PROVISIONS.

Bill No. 810, 2001 Legislative Session

A BILL TO AMEND TALBOT COUNTY CODE SECTION 11-5(a) PERTAINING TO "PUBLIC LANDINGS" TO PROVIDE THAT DOCKING AND RAFTING IN DOGWOOD HARBOR SHALL BE ALLOWED BY A PERMIT LIMITED TO VESSELS UNDER FIFTY (50) FEET, SKIPJACKS, AND BUYBOATS.

Bill No. 811, 2001 Legislative Session

A BILL TO REPEAL AND RE-ENACT ARTICLE 2, SECTION 2-4(d)(1) OF THE TALBOT COUNTY CODE ENTITLED "ALCOHOLIC BEVERAGES" TO ELIMINATE THE PROVISION THAT A HOLDER OF A CLASS "C" LICENSE MAY ALSO HOLD A CLASS 4 LIMITED WINERY LICENSE.

Bill No. 813, 2001 Legislative Session

A BILL TO LIMIT STORAGE AND PLACEMENT OF TOBACCO PRODUCTS OFFERED FOR SALE IN TALBOT COUNTY, TO REQUIRE THAT THEY BE ACCESSIBLE TO THE BUYER ONLY THROUGH THE INTERVENTION OF THE RETAIL SELLER; EXEMPTING TOBACCO STORES, AND EXEMPTING
