A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT LESS THAN \$5 AND NOT EXCEEDING \$50 FOR EACH VIOLATION.

8-802. METHYL ALCOHOL IN MEDICATION.

(A) DEFINITIONS.

- (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
- $\,$ "DRUG" MEANS A DRUG, MEDICINE, OR A MEDICINAL OR CHEMICAL PREPARATION FOR INTERNAL HUMAN CONSUMPTION.
 - (3) "PREPARE" MEANS TO MAKE, MIX, MANUFACTURE, OR COMPOUND.

(B) PROHIBITED.

A PERSON WHO IS ENGAGED IN THE BUSINESS OF PREPARING OR DISPENSING A DRUG FOR INTERNAL HUMAN CONSUMPTION MAY NOT PREPARE, DISPENSE, SELL, OR DELIVER THE DRUG TO A PERSON DIRECTLY OR THROUGH AN AGENT OR EMPLOYEE IF:

- (1) ETHYL ALCOHOL IS USUALLY USED TO PREPARE THE DRUG; AND
- (2) THE PREPARER, OR THE PREPARER'S AGENT OR EMPLOYEE, IN ANY MANNER USES OR SUBSTITUTES METHYL ALCOHOL FOR ETHYL ALCOHOL, OR PUTS METHYL ALCOHOL INTO THE DRUG.

(C) PENALTY.

A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT FOR NOT LESS THAN 3 MONTHS AND NOT EXCEEDING 1 YEAR OR A FINE OF NOT LESS THAN \$100 AND NOT EXCEEDING \$500 OR BOTH.
