03-R-14 As Amended

AMENDED RESOLUTION

OF THE MAYOR AND COUNCIL OF THE CITY OF COLLEGE PARK, MARYLAND, ENLARGING THE CORPORATE BOUNDARIES OF THE CITY BY ANNEXING LAND CONTIGUOUS TO AND ADJOINING THE EXISTING CORPORATE AREA INCLUDING THE PROPERTIES KNOWN AS THE IKEA PROPERTY AND THE HOLIDAY INN PROPERTY, A PORTION OF U.S. ROUTE 1 ABUTTING THOSE PROPERTIES, AND THAT PORTION OF THE U.S. ROUTE 1 AND I-95 INTERCHANGE NOT PRESENTLY WITHIN THE CITY AND CONTAINING APPROXIMATELY 72± ACRES.
