AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND TO REPEAL AND REENACT ARTICLE II, SECTION 144-7 OF CHAPTER 144 OF THE DORCHESTER COUNTY CODE PROVIDING FOR AN INCREASE OF THE RECORDATION TAX FROM \$3.30 PER \$500 TO \$5.00 PER \$500 AND RELATING GENERALLY TO AN INCREASE IN THE RECORDATION TAX.

A RESOLUTION OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND REDUCING THE COUNTY TRANSFER TAX FROM ONE PERCENT (1%) OF THE CONSIDERATION PAYABLE FOR AN INSTRUMENT OF WRITING TO SEVENTY FIVE ONE HUNDREDTHS OF A PERCENT (0.75%) OF THE CONSIDERATION PAYABLE FOR AN INSTRUMENT OF WRITING BY AMENDING ARTICLE VIII, SECTION 144-20(C) OF CHAPTER 144 ENTITLED "TAXATION" OF THE DORCHESTER COUNTY CODE.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY TO ADD NEW CHAPTER 133 ENTITLED "SHORE EROSION CONTROL DISTRICTS" TO THE DORCHESTER COUNTY CODE, FOR THE PROTECTION OF THE WELFARE AND HEALTH OF DORCHESTER COUNTY, THE CHESAPEAKE BAY AND THE WATERS OF THE STATE OF MARYLAND, FROM EROSION OF SHORELINES, TO RETARD EROSION AND THE DEPOSIT OF ERODED SEDIMENTS IN THE WATERS OF THE STATE AND DORCHESTER COUNTY, AUTHORIZING THE ESTABLISHMENT OF SHORE EROSION CONTROL DISTRICTS WITHIN DORCHESTER COUNTY, PROVIDING FOR PROCEDURES FOR THE ESTABLISHMENT OF SHORE EROSION CONTROL DISTRICTS, THE LEVY OF BENEFIT CHARGES AND THE LIEN THEREOF FOR PROPERTY BENEFITED, THE LEVY OF TAXES TO FINANCE SHORE EROSION CONTROL DISTRICTS, AND THE FINANCING OF SHORE EROSION CONTROL DISTRICTS AND RELATING GENERALLY TO SHORE EROSION CONTROL WITHIN DORCHESTER COUNTY.

Bill No. 2003-6

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND TO ADD NEW SECTION 10-8.3 TO ARTICLE 10 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND TO PROVIDE THAT COUNTY COUNCIL MEMBERS WHO HAVE NOT BEEN REELECTED AT THE GENERAL ELECTION IN NOVEMBER OR THE PRIMARY ELECTION IN SEPTEMBER OF AN ELECTION YEAR MAY NOT MAKE APPOINTMENTS TO COUNTY BOARDS AND/OR COMMITTEES.
