

AUTHORIZE AND EMPOWER THE COUNTY COMMISSIONERS OF KENT COUNTY, FROM TIME TO TIME, TO BORROW NOT MORE THAN FIFTEEN MILLION DOLLARS (\$15,000,000) FOR THE PUBLIC PURPOSES OF FINANCING OR REFINANCING GENERAL OPERATING EXPENSES OR CAPITAL IMPROVEMENTS, ALL AS MORE PARTICULARLY DESCRIBED HEREIN, AND TO EVIDENCE SUCH BORROWING BY THE ISSUANCE AND SALE AT PUBLIC OR PRIVATE SALE, UPON ITS FULL FAITH AND CREDIT, OF ONE OR MORE SERIES OF ITS GENERAL OBLIGATION BONDS IN LIKE PAR AMOUNT; EMPOWERING AND DIRECTING THE COUNTY COMMISSIONERS OF KENT COUNTY TO ADOPT A RESOLUTION IN ACCORDANCE WITH SECTION 15(4) OF ARTICLE 25B OF THE ANNOTATED CODE OF MARYLAND, AS AMENDED FROM TIME TO TIME, PRIOR TO ISSUING ALL OR ANY PART OF THE BONDS; EMPOWERING AND DIRECTING THE COUNTY TO LEVY AD VALOREM TAXES IN RATE AND AMOUNT SUFFICIENT TO PROVIDE FUNDS FOR THE PAYMENT OF THE MATURING PRINCIPAL OF AND INTEREST ON THE BONDS AND PLEDGING THE COUNTY'S FULL FAITH AND CREDIT AND UNLIMITED TAXING POWER; EXEMPTING THE BONDS FROM THE PROVISIONS OF SECTIONS 9 TO 11, INCLUSIVE, OF ARTICLE 31 OF THE ANNOTATED CODE OF MARYLAND; AUTHORIZING THE ISSUANCE OF REFUNDING BONDS.

Bill No. 1-2006

AN ACT TO REPEAL AND RE-ENACT WITH AMENDMENTS CHAPTER 54 OF THE CODE OF PUBLIC LOCAL LAWS OF KENT COUNTY, MARYLAND (1994 EDITION), FOR THE PURPOSE OF ABOLISHING THE POSITION OF TREASURER AT THE CONCLUSION OF THE PRESENT TERM OF SUCH OFFICE; AND DESIGNATING A CHIEF FINANCE OFFICER OF KENT COUNTY TO BE AND SERVE AS THE COLLECTOR OF TAXES FOR KENT COUNTY.

AN ACT TO AMEND SECTION 33-1 OF CHAPTER 33 OF THE CODE OF PUBLIC LAWS OF KENT COUNTY (1994 EDITION) TO ESTABLISH AN EMERGENCY SERVICES BOARD; PROVIDING FOR THE MEMBERSHIP, TERMS, AUTHORITY, DUTIES, AND QUORUM OF THE BOARD; ESTABLISHING PROCEDURES FOR THE DISTRIBUTION OF THE ANNUAL APPROPRIATIONS FOR EMERGENCY SERVICES FOR THE USE AND BENEFIT OF THE FIRE
