McCready of John and also for and in Consideration of the Sum of one dollar Current money to me in hand paid by the said James McCready at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged have bargained given and delivered and by these presents do give bargain and deliver unto the said James W. McCready one fourth of a negro man named James Alfred aged about twenty seven years, it being all my right of said negro man, also one small house which I have heretofore used as a store house, and one bedstead and furniture, To Have and To Hold the said one fourth of the said negro man, and the other property above mentioned unto the said James W. McCready his executors administrators and assigns to his and their own proper use and benefit forever and I the said Samuel McCready my heirs executors and administrators unto the said James W. McCready his executors, administrators and assigns from and against all person and persons whomsoever shall and will warrant and forever defend by these presents
