Grasier his Executors administrators and assigns all the crop of corn now growing on the place on which I now reside called Long Point also all the goods household stuff implements and furniture, in the house in which I now reside and all which I now own or possess consisting of beds bedsteads, tables bureaus chairs clock and kitchen furniture and all my farming utensils and stock particularly mentioned and described in the schedule hereunto annexed all and singular of which said goods and Chattels are now in and upon the place where I now reside called Long Point To Have and To Hold all and singular the said goods, crop, household, stuff stock and farming utensils above bargained and sold
