



Dunrock of Baltimore City, in the State of Maryland, for and in consideration of the sum of Eight Hundred Dollars, current money of Maryland, to me in hand paid by Levin A. Insley of Dorchester county in the State of Maryland, at and before the sealing and delivering of these presents, the receipt whereof I the said Sophia Dunrock, do hereby acknowledge, have granted, bargained and sold, and by these presents do grant, bargain and sell unto the said Levin A. Insley, his heirs, Executors, administrators and assigns, the following negroes slaves for life, and now in the possession of the said Levin A. Insley, to wit: negro woman Henrietta; aged about thirty six years, and her four youngest children viz. Hannah, aged about seven years, Rachel, aged about six years, Thomas, aged about two years and six months, and Levin aged about sixteen months, the said negro woman Henrietta, is sold to the said Levin A. Insley, to remain in Dorchester County, and not to be carried beyond the limits of said County, unless for some criminal offence. To Have and To Hold the said negroes, Henrietta, Hannah, Rachel and Levin as above bargained and sold, or mentioned, or intended, so to be, to the said Levin A. Insley, his heirs, Executors, administrators and assigns forever, and I the said Sophia Dunrock, for myself, my heirs, Executors and administrators, all and singular the said negroes Henrietta, Hannah, Thomas and Levin, and other the premises, unto the said Levin A. Insley, his Executors, administrators and assigns, against me the said Sophia Dunrock, my Executors and administrators, and against all and every other person or persons whatsoever, shall and will warrant and forever defend by these presents. In Witness whereof, the said Sophia Dunrock, hath hereunto set her hand and affixed her seal this third day of June, in the year of our Lord one thousand eight hundred and fifty six
