This Indenture, made this thirteenth day of October, in the year Eighteen hundred and fifty eight, between

William H. Ross, Charles Wright and William W. Culam, of Sussex County, in the State of Delaware, of the one part, and the Farmers and Merchants Steamboat Company of Nanticoke River, in the State of Maryland, of the other part. Whereas the said Farmers and Merchants Steamboat Company of Nanticoke River, by their Indenture of Mortgage bearing date on the nineteenth day of September, eighteen hundred and fifty four, duly executed, acknowledged and recorded in Liber D. N. No. 2, folios 177 & one of the Chattel Records of Dorchester County, and State of Maryland, did, for and in consideration of the sum of Twelve thousand dollars, grant, bargain and sell, assign and convey unto Edward G. Sturgeon, James Murray and Henry R. Hazlehurst, the Steamboat called the Kent, which was built in Baltimore, in the year eighteen hundred and fifty four, and which is enrolled according to law at the port of Baltimore, as appears by the enrollment thereof, dated on the fifth day of July, in the year Eighteen hundred and fifty four, and numbered one hundred and fifty three, together with her engines and machinery, tackle, boats, apparel and furniture, a reference being had to the above recited Deed of Mortgage well more fully and at large appear: And whereas the said Edward G. Sturgeon, James Murray and Henry R. Hazlehurst, did on the twenty seventh day of July, eighteen hundred and fifty five, by Indenture duly executed and recorded in Liber D. N. No. 2, folios 171 & one of the Chattel Records for Dorchester County aforesaid, assign and transfer unto the said parties of the first part, being the balance thereof due and owing to said Edward G. Sturgeon, James Murray and Henry R.
