Jefferson, of the County and State aforesaid, at and before the sealing and delivery of these presents, the receipt whereof I the said Reuben S. Tall, do hereby acknowledge, have granted, bargained and sold, and by these presents, do grant, bargain and sell unto the said Geo. W. Jefferson, his executors, administrators and assigns, all the Goods, Chattels and Personal Property, hereinafter particularly mentioned and expressed, that is to say: the Printing press, Cases, Furniture and materials in the Office of the "American Eagle", newspaper, all and singular which said Goods, Chattels and Personal Property, are now remaining standing and being in a certain Messuage or Tenement situated in the Town of Cambridge, and now in the occupancy of the said Geo. W. Jefferson, to have and to hold all and singular the said Printing press, cases, type, Furniture and materials, and other the premises above bargained and sold or mentioned or intended so to be to the said Geo. W. Jefferson, his executors, administrators and assigns forever; and I the said Reuben S. Tall, for myself, my heirs, executors and administrators all and singular, the said Printing press, type and cases, Furniture and materials, and other the premises unto the said George W. Jefferson, his executors, administrators and assigns, against me the said Reuben S. Tall, my executors and administrators, and against all and every other person or person whatsoever: shall and well warrant and forever defend by these presents.
