 Know all men by these presents, that I
 Caleb Hubbard of Dorchester County in the State of Maryland for &
 in consideration of the sum of Five hundred & five \$ dollars &
 seventy five cents, Current Money to me in hand paid by Eliza Jane
 Hubbard my wife of Dorchester County in the said State at & before
 the sealing & delivering of these presents, the receipt whereof I the said
 Caleb Hubbard do truly acknowledge have granted, bargained
 & sold & by these presents do grant, bargain & sell unto the said
 Eliza Jane Hubbard her Executors, Administrators, & assigns
 all the named property as follows, One Horse & Carriage, One yoke of
 Oxen, One Ox cart, One Cow, two yearlings, three sheep, One Sow
 & three hogs, a Crop of wheat on the ground eight hundred of
 Corn, & odder, five hundred pounds of Pork, two Beds & six
 stools, all and singular which goods & chattels are now remain-
 ing standing & being in Meekins Meek, in the occupation of the
 said Caleb Hubbard, to have & to hold all and singular the said
 property above mentioned bargained & sold or mentioned & inten-
 ded to be, to the said Eliza Jane Hubbard her Executors
 Administrators and assigns forever, and I the said Caleb Hub-
 bard for myself my heirs, Executors and Administrators all
 singular the said property, herein mentioned & other the premises unto
 the said Eliza Jane Hubbard her Executors Administrators and
 assigns & theirs all & every other person or persons whatsoever that
 shall hereafter & forever defend by these of all & singular which said
 goods & chattels & other the premises I the said Caleb Hubbard
 have put the said Eliza Jane Hubbard in full possession by deli-
 vering the said property to her Eliza Jane Hubbard all the property
 herein mentioned at the sealing & delivering of these presents in the
 name of the whole premises truly bargained and sold or men-
 tioned & intended to be unto her, the said Eliza Jane Hubbard
