 from & I that the following Bill of Sale was made and
 Caleb Hubbard I recited the 4th day of January 1859 to wit:
 I know all truly these presents that I
 Caleb Hubbard of Dorchester County in the State of Maryland for &
 in consideration of the sum of Five hundred & five Dollars &
 Seventy five cents, Current money to me in hand paid by Eliza Jane
 Hubbard my wife of Dorchester County in the said State at & before
 the sealing & delivering of these presents, the receipt whereof I the said
 Caleb Hubbard do hereby acknowledge have granted, bargained
 & sold & by these presents do grant, bargain & sell unto the said -
 Eliza Jane Hubbard her Executors Administrators & assigns
 all the named property as follows. One Horse & carriage, One yoke of
 Oxen, One Oxcart, One Cow, two yearlings, three Sheep, One Sow
 & three Hogs, a Crop of Wheat on the ground Eighteen barrels of
 Corn, & fodder, five hundred pounds of Pork, Two Beds, Six
 Stools, all and singular which goods & chattels are now remain-
 ing standing & being in Meekins Neck, in the occupation of the
 said Caleb Hubbard, to have & hold all and singular the said
 property above mentioned bargained & sold or mentioned & inten-
 ded to be, to the said Eliza Jane Hubbard her executors
 administrators and assigns forever, and I the said Caleb Hub-
 bard for myself my heirs, Executors and administrators all
 singular the said property, herein mentioned to her the premises unto
 the said Eliza Jane Hubbard her executors administrators and
 assigns & furnish all & every other person or persons whatsoever shall
 & will tenant & forever defend by these sealed & singular which said
 Goods & chattels to her the premises I the said Caleb Hubbard
 have put the said Eliza Jane Hubbard in full possession by deli-
 vering the said property to her Eliza Jane Hubbard all the property
 herein mentioned at the sealing & delivery of these presents on the
 name of the whomever she may have bargained and sold or men-
 tioned & intended to be unto her, the said Eliza Jane Hubbard
 as aforesaid witness my hand and seal this twentieth day of
 December in the year eighteen hundred and fifty eight
