 above bound James R. Wheatley collector of the direct Tax of District No. 1 or  
 Fork in Dorchester County Shall well and faithfully execute the Office of Collector  
 of the direct Tax for the Said district in Said County and the several duties required  
 of him by Law, and shall well and truly account for and pay to the Treasury of  
 Maryland the several sums of money which he shall receive or be answerable for by  
 Law at such times as the Law shall direct then the above obligation to be void, or  
 else to be and remain in full force and virtue in Law
