Know all men by these presents that we Alexander Woolford, Thomas Woolford, Joseph Brooks and Thomas Bromwell all of Dorchester County in the State of Maryland are held and firmly bound unto the State of Maryland in the full and just sum of One thousand Dollars current money to be paid to the said State or its certain attorney to the which payment well and truly to be made and done, we bind ourselves, and each of us, our and each of our heirs, executors and administrators, jointly and severally, firmly by these presents. Sealed with our seals and dated this the 25th day of July in the year of our Lord one thousand eight hundred and fifty nine. — The condition of the above obligation is such that if the above bound Alexander Woolford appointed Collector of the Direct Tax of the Fourth Election District for Dorchester County, shall well and faithfully execute the office of Collector of the Direct Tax of the Fourth Election District for Dorchester County, and the several duties required of him by law, and shall well and truly account for and pay to the Treasurer of Maryland the several sums of money which he shall receive or be answerable for by law, at such time as the law shall direct then the above obligation to be void, or else to be and remain in full force and virtue in law.
