- (B) THE DEPUTY COMMISSIONER SERVES AT THE PLEASURE OF THE COMMISSIONER.
- (C) THE DEPUTY COMMISSIONER SHALL BE THE ACTING COMMISSIONER IN THE ABSENCE OF THE COMMISSIONER.
- (A) THERE IS A PRETRIAL RELEASE SERVICES PROGRAM, WHICH SHALL BE PART OF THE DIVISION, AND THE HEAD OF WHICH SHALL BE THE DIRECTOR OF PRETRIAL RELEASE SERVICES. THE DIRECTOR AND THE DEPUTY DIRECTOR SHALL BE APPOINTED BY THE COMMISSIONER, WITH THE APPROVAL OF THE SECRETARY, TO SERVE AT THE PLEASURE OF THE COMMISSIONER. THE SALARIES OF THE DIRECTOR AND DEPUTY DIRECTOR SHALL BE AS PROVIDED IN THE ANNUAL STATE BUDGET.
- (B) SUBJECT TO THE AUTHORITY OF THE COMMISSIONER, THE PRETRIAL RELEASE SERVICES PROGRAM SHALL, IN ADDITION TO ANY OTHER DUTIES PROVIDED FOR BY LAW, PERFORM THE PRETRIAL RELEASE DUTIES FORMERLY PERFORMED BY THE PRETRIAL RELEASE SERVICES DIVISION OF THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES, THE PRETRIAL RELEASE COMMITTEE, AND THE DIVISION OF PAROLE AND PROBATION.

- (A) THERE IS A BALTIMORE CITY DETENTION CENTER WHICH IS PART OF THE DIVISION.
- (B) THE BALTIMORE CITY DETENTION CENTER IS A PRETRIAL DETENTION FACILITY FOR ANY PERSON COMMITTED OR TRANSFERRED TO THE CUSTODY OF THE COMMISSIONER.
- (C) THE SECRETARY MAY AUTHORIZE THE HOUSING, IN THE BALTIMORE CITY DETENTION CENTER, OF ANY PERSON HELD IN CUSTODY UNDER ANY AGENCY OF THE DEPARTMENT.

- (A) WITH THE APPROVAL OF THE SECRETARY, THE COMMISSIONER SHALL APPOINT A WARDEN OF THE BALTIMORE CITY DETENTION CENTER.
- (B) THE WARDEN OF THE BALTIMORE CITY DETENTION CENTER SERVES AT THE PLEASURE OF THE COMMISSIONER.
- (C) THE WARDEN IS IN CHARGE OF THE BALTIMORE CITY DETENTION CENTER, SUBJECT TO THE AUTHORITY OF THE COMMISSIONER AND THE SECRETARY.
