

area or district, and shall be deemed and taken to comprise certain parcels of land, namely;

So much of the area in the subdivision of land in [said] Montgomery County made by Bedford W. Walker and known as Kenilworth, as per Plat No. 7 in Plat Book No. 1, recorded among the Land records of [said] Montgomery County, Maryland, and such territory adjacent thereto as is included in the following boundaries; the North line of Jones [Mill] BRIDGE Road on the South; the East line of [the State road] CONNECTICUT AVENUE, MARYLAND ROUTE 185 on the West; [the North Boundary of Kenilworth as platted in said records on the North; and the East boundary of Kenilworth as platted in said records] A LINE APPROXIMATELY 100 FEET NORTH OF HUSTED DRIVE EXTENDING WEST TO CONNECTICUT AVENUE ON THE NORTH; AND THE WEST SIDE OF CLIFFORD AVENUE EXTENDING FROM THE NORTH BOUNDARY TO JONES BRIDGE ROAD on the East. The area so bounded shall be known for the purpose of this Act as THE VILLAGE OF North Chevy Chase, Montgomery County, Maryland.

SECTION 2. AND BE IT FURTHER ENACTED, That the County Council for Montgomery County is authorized, empowered and directed to levy and cause to be collected from the property owners, at the time of the County Tax Levy for [the year 1924, or any succeeding year, within said described area of North Chevy Chase as named or created in this sub-title, such amounts not exceeding fifty cents on each one hundred (100) dollars worth of assessable property in said part of the Village of North Chevy Chase, Montgomery County, Maryland, as may be requested by a majority vote of the resident real estate owners of legal age, who are assessed as owners of real estate in such area present at a meeting called for such purpose by the Citizens' Committee hereinafter provided for, notice of which meeting shall have been mailed to all such resident owners at least two weeks in advance of the meeting. Such taxes shall be collected as all county taxes in said county are collected, and shall be paid over by the County Council to the Treasurer of said Citizens' Committee of the Village of North Chevy Chase, to be selected from among their number by a majority of the members of said Citizens' Committee, or by their successors to be selected as herein provided. Upon said Treasurer having been duly selected by such committee and having given corporate bond to Montgomery County, Maryland, satisfactory to and approved by the County Manager and the County Attorney in a penal sum to be fixed by them, conditioned upon the faithful discharge of the duties of said Treasurer, the said County Council shall also order and have paid over to said Treasurer the proportion of the county road tax to be levied and collected in the same manner as though said part of said Village of North Chevy Chase were an incorporated town, and said part of said village shall for that purpose be considered by said Council as an incorporated town of said county; and said proportion of the county road tax received by said Treasurer of said Committee shall be used by said Committee exclusively for maintaining and repairing the county roads, streets and lanes that may have been dedicated to the public or to Montgomery County, and whether accepted by said county or not; all other funds to be used by the said Committee directly, or through said Committee, exclusively, for opening, maintaining, repairing, regrading and lighting the streets, roads and alleys, of sidewalks, parking, drainage, sewerage, sanitation and other village maintenance and improvements; for clerical and other public services; for furnishing police and fire protection; for the removal of snow, ice, ashes,
