PROPERTIES SITUATED IN THE VILLAGE; FOR ENFORCING SUCH BUILDING, SANITARY AND OTHER REGULATIONS AS THE VILLAGE COUNCIL, SUBJECT TO THE COUNTY COUNCIL'S APPROVAL, MAY PRESCRIBE FOR THE VILLAGE OF NORTH CHEVY CHASE OR FOR ANY PART OF THE VILLAGE OF NORTH CHEVY CHASE.

SECTION 3. AND BE IT FURTHER ENACTED, That [from and after the passage of this Act until the first Monday in April, 1925, the said Citizens' Committee of North Chevy Chase shall be constituted as follows: Richard H. Gangwisch, L. Vaughn Bowly, Alfred G. Buhrman, Robert H. Simpson and William L. Lanning, and the first named shall, until otherwise directed by said committee be and constitute the Chairman thereof, each of whom shall qualify as such committeemen by taking an oath before any officer in Montgomery County authorized by law to administer oaths; to diligently and faithfully discharge all duties of the said office. In case any such persons shall fail to qualify within thirty days after the passage of this act, or if any of their successors shall fail to qualify within thirty days after his election as committeeman, as hereinafter provided, or in case of any vacancy through death, resignation, or otherwise, the remaining committeemen shall fill such vacancy by the appointment of a resident of said village, of legal age, and owner of real property in said village, who shall hold office for such term or unexpired term.

On the first Monday in April, 1925, two members of the said Citizens' Committee shall be elected to serve for one year, and three members to serve for two years. On the first Monday in April, 1926, and on the first Monday in April of each succeeding year an election shall be held at which committeemen shall be elected for two years to succeed those whose terms expire and which committeemen shall be elected to fill any vacancies which may exist, but the committeemen so elected to fill such vacancies shall serve for the remainder of the unexpired term only. The election shall be by ballot in a manner to be prescribed by said committee. Only residents of legal age of said village who shall have resided therein for not less than six months next preceding said election, shall be entitled to vote for or hold the office of committeeman in said village. Following each election each newly elected member of said committee shall qualify by taking the oath prescribed as aforesaid. Said committee shall select from their members a chairman, secretary, treasurer and any other officers as they may deem necessary.] THE VILLAGE COUNCIL OF THE VILLAGE OF NORTH CHEVY CHASE SHALL CONSIST OF FIVE ADULT RESIDENTS OF THE VILLAGE OF NORTH CHEVY CHASE, EACH OF WHOM SHALL BE ELECTED FOR TWO-YEAR, STAGGERED TERMS. TWO MEMBERS OF THE COUNCIL SHALL BE ELECTED ON THE FIRST MONDAY OF APRIL DURING ODD-NUMBERED YEARS AND THREE MEMBERS SHALL THE **MONDAY** OF APRIL **FIRST** ELECTED ON EVEN-NUMBERED YEARS. THE ELECTION SHALL BE BY BALLOT IN A MANNER TO BE PRESCRIBED BY THE VILLAGE COUNCIL.

RESIDENTS OF THE VILLAGE WHO ARE REGISTERED TO VOTE WITH THE MONTGOMERY COUNTY BOARD OF SUPERVISORS OF ELECTIONS SHALL BE DEEMED TO BE REGISTERED TO VOTE IN VILLAGE ELECTIONS. OTHER VILLAGE RESIDENTS WHO ARE QUALIFIED TO VOTE IN MONTGOMERY COUNTY MAY REGISTER TO VOTE IN VILLAGE
