

Washington County Code of Public Local Laws

FOR the purpose of revising the Code of Public Local Laws of Washington County; making stylistic changes; adding certain erroneously omitted language; amending certain obsolete or erroneous cross-references; repealing certain obsolete provisions of law that concern the powers and duties of the Washington County Health Officer; repealing certain obsolete provisions of law concerning prisoners, the Board of Health, the Health Officer, school bus transportation, the Register of Wills, court stenographers, witnesses, and jurors; amending certain references to units of State government; legalizing the 1991 Edition and its supplements of the Code of Public Local Laws of Washington County; making provision for the publication, sale, and distribution of this Code; providing for the construction of this Act; and generally relating to the revision and updating of the Code of Public Local Laws of Washington County.
