[3-508. Same; compensation for grand jury work.

The official court stenographer shall receive and be compensated for his services at the rate of \$5 a day or portion of a day. (1957 Code, sec. 146. 1939, ch. 282, sec. 115B; 1970 ed. sec. 4-24; 1984, ch. 289)]

[3-509. Same; violation of duty of secrecy.

If the official court stenographer violates any of the provisions of section 3-507 with regard to secrecy, the stenographer is guilty of a misdemeanor and shall be subject to a fine not exceeding \$1,000 or imprisonment for a period not exceeding 1 year, or both. [3-601.] 3-401. Sessions.

The sessions of the Orphans' Court of Washington County shall be held on Tuesday and Friday of each week from 10 a.m. until 3 p.m., and on other days as in the judgment of the Court the public business and convenience requires. [3-602.] 3-402. Levy for salary; payment.

The County Commissioners shall levy annually an amount that they estimate will be sufficient to pay the Judges of the Orphans' Court for the next ensuing year. The Register of Wills shall certify monthly to the County Commissioners the number of days each of the Judges has attended the Court during the month, and the [tax collector] TAX COLLECTOR shall pay to each of the judges the amount prescribed by [Section 2-108(v)] § 2-108(V) of the Estates and Trusts Article for each day's attendance certified by the Register of Wills. [3-701. Payment for witnesses.

The county commissioners shall pay State's witnesses in the county promptly at the close of each term of the circuit court. (P.L.L., 1860, Art. 21, sec. 335; 1888, Art. 22, Sec. 424; 1930, sec. 865; 1957 Code, sec. 830; 1970 ed. sec. 40-1; 1984, ch. 289)]

[3-702. Orders for payment.

Whenever any person presents to the collector of the county an order from the clerk of the circuit court for the person's attendance as a witness, the clerk shall pay to the person, or to the person's order, the amount due the person, after deducting all charges
