

(b) Prohibitions. Goods, wares, or merchandise may not be sold at or during the sale, excepting the goods, wares, or merchandise described and inventoried in the original application. (1961, ch. 804, sec. 167D; 1970 ed. sec. 7-4; 1984, ch. 289)

5-105. Termination date.

A person may not:

(1) Conduct a closing-out sale or a sale of goods, wares, or merchandise damaged by fire, smoke, water, or otherwise beyond the termination date specified for the sale, except that an extension may be authorized upon proper showing of need;

(2) Upon conclusion of the sale, continue that business which had been represented as closing out or going out of business under the same or different name, at the same location, or elsewhere in Washington County where the inventory for the sale was filed; or

(3) Upon conclusion of the sale, continue business contrary to the designation of the sale. (1961, ch. 804, sec. 167E; 1970 ed. sec. 7-5; 1984, ch. 289)

5-106. Penalty provisions.

Any person who advertises, holds, conducts, or carries-on any sale of goods, wares, or merchandise under the description of closing-out sale or a sale of goods, wares, or merchandise damaged by fire, smoke, water or otherwise, contrary to the provision of this subtitle, or who violates any of the provisions of this subtitle is guilty of a misdemeanor and shall be fined not more than \$1,000 or imprisoned for not more than 90 days, or both. 5-107. Exceptions.

The provisions of this subtitle do not apply to public or court officers, or to any other person or persons acting under the license, direction, or authority of any local or federal court who sell goods, wares, or merchandise in the course of their official duties. (1961, ch. 804, sec. 167G; 1970 ed. sec. 7-7; 1984, ch. 289)

5-108. Jurisdiction of Circuit Court.

Upon complaint of any person, the Circuit Court for Washington County has jurisdiction in equity to restrain and enjoin any act forbidden or declared illegal by any provision of this subtitle. (1961, ch. 804, sec. 167H; 1970 ed. sec. 7-8, 1984, ch. 289)

5-109. Regulations.

The County Commissioners may adopt ordinances or regulations to carry out the purposes of this subtitle, including regulations limiting the period of time a closing-out sale or a sale of goods, wares or merchandise damaged by fire, smoke, water, or otherwise may be conducted, subject to extension provisions. A regulation may not be put in effect until after a public hearing has been held. (1961, ch. 804, sec. 167-I; 1970 ed. sec. 7-9; 1984, ch. 289)
