

may use the amount paid to it for the system for the purchase or redemption of any bonds or debt which are outstanding against it, or the Commission, as a part of the purchase price of the system, may assume the payment of the outstanding bonds. The Commission may not wholly or partially purchase any existing water mains, sewers, or systems which are improperly constructed, are not of sufficient capacity, or were constructed without proper authority from the State Department of Health since the passage of the law requiring them. 6-902. Commission to supervise other systems.

(a) Private system. Whenever the County, the property owners, or the residents of any locality in a [sub-district] SUBDISTRICT want all or part of a water system, sewerage [system] SYSTEM, or surface water drainage system to be constructed in that locality, and the Commission decides that it is inexpedient or impracticable at that time to build the system, those persons may build and operate the system at their own expense.

(b) Control of Commission. It shall be constructed under plans and specifications prepared by the Commission or under its supervision, and its maintenance and operation shall be under the general control of the Commission.

(c) Prohibition. All or part of the system, water main, sewer, water purification or sewage treatment plant, or connection with any of them, may not be constructed or installed except as provided in this section. Any violation of this provision is a misdemeanor punishable under [Section 6-1004] § 6-1004 OF THIS TITLE.

(d) Filing records. All construction, operating records, and cost records shall be filed with the Commission. The Commission may take over [system] all or part of the SYSTEM, water main, sewer, [storm water] STORMWATER drain, water or sewage treatment plant, or connect on with any of them in the same manner as provided under [Section 6-901] § 6-901 OF THIS SUBTITLE for systems existing on June 1, 1957. Subtitle 10. Miscellaneous Provisions

6-1001. Right of entry.

An employee or agent of the Commission has the right of entry, at all reasonable hours, upon any private premises and into any building in a [sub-district] SUBDISTRICT, while in pursuit of [his] THE official duties OF THE EMPLOYEE OR AGENT, upon first presenting proper credentials from the Commission. Any restraint or hindrance offered to entry by any owner, tenant, agent of the owner or tenant, or any other person, is a misdemeanor punishable under [Section 6-1004] § 6-1004 OF THIS SUBTITLE.
