

each year [he] THE OFFICIAL held office[; provided, however, that] HOWEVER, the maximum annual retirement salary [shall] MAY not exceed [eighty] 80 percent [(80%)] of the highest annual salary the person received while holding one [(1)] of those offices[, and provided, further, that]. FURTHER, the amount of any pension being paid to a person by reason of retirement from employment with the county shall be subtracted from any retirement salary payable under this subsection.

(3) The annual retirement salary provided for in this subsection shall be paid to the recipient on a monthly basis.

Chapter 48

FISCAL SERVICES, DEPUTY COUNTY ADMINISTRATOR FOR

48-1.

A. Appointment [of Director] authorized; bond required; term and qualifications. There is [hereby established the] AN office of the [Director of Finance] DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES of Charles County[, and the]. THE County Commissioners [of Charles County are hereby authorized to] MAY appoint a [Director of Finance] DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES at a salary to be fixed by [said] THE COUNTY Commissioners. [Said Director] THE DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES shall hold office for a term as directed by the County Commissioners and [will] SHALL execute in favor of the County Commissioners [of Charles County] a bond [of such] IN AN amount as [they shall] THE COUNTY COMMISSIONERS prescribe, with AN appropriate corporate surety to be approved by [them] THE COUNTY COMMISSIONERS. The premium for the bond shall be paid out of county funds. The [Director] DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES shall be selected solely on the basis of [his] executive, administrative and fiscal abilities, with particular reference to [his] actual experience in the knowledge of accepted practice and procedure respecting duties of [his] THE office as set forth in this chapter.

B. Administrative responsibilities. The [Director of Finance] DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES shall devote [his] full time to the work of the county, and [he] shall be responsible to the County Commissioners for the proper administration of [his] THE OFFICE'S affairs. The [Director of Finance] DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES may employ, with the approval of the County Commissioners, [such assistance as he may deem necessary] ASSISTANTS for the proper performance of [his] THE duties OF THE OFFICE. [He] THE DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES shall at all times be held responsible for the proper discharge of [his] THE duties OF THE OFFICE, but may delegate such authority [as he deems necessary] to carry out the duties of [his] THE office to appropriate officers and employees. During [his] A temporary absence or disability, the duties of the [Director of Finance] DEPUTY COUNTY ADMINISTRATOR FOR FISCAL SERVICES shall be performed by a qualified administrative officer of the county designated, in writing, by the [Director] DEPUTY
