[such] THE terms and conditions as [may be fixed] SET by the County Commissioners prior to the issuance of the bonds. The County Commissioners, by [such] THE authorizing resolution, also shall determine the form of the bonds, including any interest coupons to be attached [thereto], any provisions for registration of the bonds or coupons, the manner of execution of the bonds, the denomination or denominations of the bonds, the place [or places] of payment of principal and interest, which may be at any bank or trust company, and may provide for [such] other details as are incident to the sale, issuance and delivery of the bonds. Each of the bonds shall be issued under the Seal of the county and shall be signed by the Chief executive officer and by the Clerk or Secretary of the county. All bonds issued under the provisions of this subsection shall [have and are declared to] have, as between successive holders, all the qualities and incidents of negotiable instruments under the laws of the State of Maryland. The issuance of the bonds is not subject to any limitations or conditions contained in any other law, including Article 31, §§ 9 to 11, inclusive, of the Annotated Code of Maryland[, 1971 Replacement Volume, as amended from time to time]. The County Commissioners may sell [such] THE bonds in [such] A manner, either at public or at private sale, and for [such] A price, at not less than par, as they may determine to be in the best interest of the county. Bonds issued pursuant to the authority of this subsection are [at all times] exempt from state, county and municipal taxation [of every kind whatsoever] in the State of Maryland. This subsection shall be construed as a specific grant of authority to the County Commissioners to issue and sell [such] bonds in the manner prescribed in this subsection.

B. After acquisition of a private water system, it shall be operated and maintained by the Department of [Public Works] FACILITIES pursuant to the Department's rates and regulations.
